# Never Miss an Opportunity

In a rapidly changing world, adaptation and iteration are more important than ever. COVID-19 forced organizations to shift to a distributed hybrid work environment practically overnight. Organizations survived by rapidly adopting cloud applications, but struggled with both the IT infrastructure and IT support needed to manage this dramatic digital transformation.



**The American Rescue Plan Act of 2021** (ARPA) was introduced as a means to help organizations overcome these challenges. With \$1.9 trillion made available to organizations across the country spanning every industry, it provides organizations with funding opportunities needed to help them modernize their technology environments.

This opportunity comes at a critical time for many organizations that are trying to navigate the new normal of back to the office. According to a recent Gartner survey, **84% of company leaders** plan to allow employees to work remotely for at least some of their working hours. This holistic consideration ensures these establishments can't just go back to "business as usual." Instead, these organizations should meet the opportunity to improve and meet their unique challenges and opportunities head on.

Worth noting is that though these funds were created to address the COVID crisis, they are also intended to help organizations **create more resilient technology infrastructures** to thrive today and in the future. The only constant in technology is change, and the rapid shift to remote work underscored just how much organizations need to be prepared to adapt and thrive to unforeseen circumstances.

In short, every group leader should ask themselves what technical tools might be needed to thrive amidst a similar crisis and prepare accordingly. And to do so, they should leverage every tool and opportunity available.

## WHY ARPA?

Remote work has radically shifted the composition of many industries. As a result, keeping pace with previous best practices is no longer enough. ARPA funds are designed to help companies catch up to new business realities.

For example, Gartner noted that prior to COVID-19, most customer service and support functions operated almost exclusively in-office, with fewer than 10% of customer service and support employees working from home. Now, **76% of customer service and support functions** have 80% to 100% of their staff working remotely.

These changes have disrupted more than just work; traditional security has been impacted, as well. Hewlett Packard's recent report on cyber-security notes a **238% increase in global cyberattack volume** during the pandemic, largely empowered by new remote working practices.

Risks and opportunities are both evolving; organizations can't afford to be stagnant with short-term fixes. It's time for organizations to identify long-term solutions that more

accurately align to where their needs are to secure today and prepare for tomorrow.

## APPLYING FOR FEDERAL FUNDING EXPLAINED

ARPA is a significant opportunity for applicable organizations because it is set up as a high-reward process. Despite the potential benefits and opportunities of ARPA, interested government agencies, education institutions and healthcare organizations still find themselves with tough, time-consuming challenges and considerations including:

- How to **identify** available funds
- How to best **apply** for ARPA funds
- How to best **manage** the funds they are granted
- How they can **spend** their ARPA funds

Decoding ARPA requires verifying your funding allocation totals, eligible use cases and ensuring the appropriate use of guidelines—all of which can be very time consuming and burdensome for even the most experienced organizations. The primary challenge with these six work vectors is that not every organization is prepared for every step. To qualify and apply for your ARPA funding, you must be prepared along six vectors of work:



**Research**

Identify appropriate Grants. Find and deliver the data to prove out the thesis for your unique and ARPA-compliant technology.



**Process Management**

Plan, organize and control a functional system that can meet proposal deadlines and requirements.



**Grant Writing/Justification**

Create a compelling and clear grant proposal that distinguishes your project and justifies your funding.



**Ongoing Budget Operations**

Clearly and transparently budget grant money to ensure your organization meets ARPA standards.



**Technical Compliance**

Meet technical compliance requirements across each stage, ensuring security for the project.



**Utilizing a Federally Compliant Vehicle**

Meet vetting by a federally-approved procurement sourcing agency, such as the GSA.

Additionally, slotting in a piecemeal solution to this process may not be a solution at all for your company. These six factors should be managed holistically to ensure consistency of the project end-to-end.

**SIMPLIFYING FEDERAL FUNDING WITH CONSULTING SERVICES**

Decoding ARPA to know exactly what funds are available to you and how you can leverage requires significant time and resources. Rather than managing the entire ARPA application, operations and
